West Ave. Discussions

1801 West Ave

Ben brought up the discussion that Jo Sue Howard wants to down-zone her home to SF3-H from MF4

SF3 would help with compatibility Cost is ~\$1500

If a commissioner or council member initiates the zoning change there is no charge

Commissioner needs a support letter from the owner and the neighborhood

Mark made a motion that JHNA write a letter of support to the Historic commission and the city for the zoning rollback, seconded by Bob Swaffer.

Ben expressed concern about our governance issues and should we vote.

Patrick noted that the neighborhood was notified in the agenda e-mail.

Megan commented that the neighborhood has been consistent about the issue of protecting borders.

Megan moved to close discussion, Bob called the question to vote.

Vote was unanimous in favor.

1503 West Ave Discussion

Ben has been meeting with the council members to explain the neighborhood position

Much discussion regarding West avenue and how we position the neighborhood regarding commercial vs. residential.

Patrick expressed his concern with the wording of the neighborhood resolution given to the historic commission of favoring residential over commercial for historic buildings on West Ave.

Ben will make an agenda item for a future meeting to discuss in more detail

Jeff mentioned that Joe Turner said that the city told him they would be putting parking meters in front of his office on West.

Bill mentioned that the neighborhood has always opposed parking meters on West Ave.

Downtown Austin Plan - Jay Tassin

Jay and Joe Bailey went to the Downtown Austin Plan meeting to discuss compatibility

Jay wants feedback from the neighborhood on compatibility

Jay went through a series of maps he has been working with the commission on to try to keep the compatibility next to the neighborhood borders

- Attend meetings when possible to show deeper support from the neighborhood
